Rules Enforcement Facilitators

What is a Rules Enforcement Facilitator?

A Rules Enforcement Facilitator is a OneKeyTM MLS Participant appointed by the Board of Managers to assist other Participants in the following specific issues:

- a. Cooperating Broker is having difficulty making an appointment to show.
- b. Listing Broker/Agent is not timely providing any required written instructions by the owner, stating that the property is not currently available to be shown, or there are any other owner-directed restrictions on showings or access.
- c. Listing Broker/Agent is not making timely arrangements to present an offer.
- d. If the Listing Broker does not return the provided Offer Acknowledgment Form (or some other form of Verifiable Electronic Communication) or a Sworn Declaration Statement stating the offer was presented to the owner.

Note - MLS rules concerning showings and offers apply to Office Exclusives with buyer agents.

The Facilitators only take calls from Participants. All issues should first try to be resolved between the two Brokers. If the two Brokers are not able to rectify the problem, any one of the Rules Enforcement Facilitators listed below may be called.

Please note, the Facilitators are only permitted to assist with the issues listed above.
